Definitions & Additional Fees

LABIAL DEFINITION

Braces are placed on the outside of the teeth (lip side). In some cases Braces and / or
Hugo aligners will be used, whichever is most efficient (Hybrid treatment)

TOOTH COLOURED (UPPER TEETH)

An additional amount of R5 183 is payable which is not covered by medical schemes (max 10 teeth)

TOOTH COLOURED (LOWER TEETH)

An additional amount of R3 392 is payable which is not covered by medical schemes (max 6 teeth)
